In terms of General Circular No. 14/2020, 17/2020 and 39/2020 dated 8 April, 2020. 13th April, 2020 and 31st December, 2020 respectively as issued by the Ministry of Corporate Affairs, the Company has duly provided facility to its shareholders to cast their votes through remote a voting process only.
